## **PUBLIC HEARING MINUTES**

On June 11, 2024 at 5:45pm Mayor Elizabeth Jeter and the Board of Alderman of the Village of Forest Hill conducted a Public Hearing at Forest Hill Municipal Complex, Room 2, 138 Blue Lake Rd, Forest Hill, LA 71430. Meter Jeter called the hearing to order. Roll call was as follows: Present: Mayor Jeter, Alderpersons Perkins, Spiller and Carroll, quorum met; and attorney Greg Jones and Chief of Police Glynn Dixon. Mayor Jeter read the Ordinances by title: An ordinance adopting an Amended Operating Budget of Revenues and Expenditures for the General Fund for the fiscal year beginning 7/1/2023 and ending 6/30/2024; An Ordinance adopting an Operating Budget of Revenues and Expenditures for the General Fund for the fiscal year beginning 7/1/2024 and ending 6/30/2025; An ordinance amending the rate of pay for the town clerk; An ordinance supplementing and amending an ordinance adopted on 2/23/2024 authorizing the issuance by the Village of Forest Hill, State of La, to increase the principal amount of such bonds to not to exceed \$1,9000,00, and providing for other matters in connection therewith. No public comments or questions.

On June 11,2024 at 6:00pm Mayor Jeter called the hearing to order. Quorum met as previously noted. Attorney Greg Jones read the Resolution by title: A resolution finding and determining that no petition has been filed objecting to the proposed issuance of Taxable Utilities Revenue Bonds of the Village of Forest Hill, State of La not to exceed \$ 1,900,000.; authorizing the officials of the Village to proceed with the preparation of the documents required for the issuance of the Bonds, and providing for other matters in connection therewith. The mayor asked if there were any objections or if anyone had filed a petition with the Clerk of Court, no response. There were no public comments or questions.
